

Call for applications of non EU citizens residing outside Italy

The [University of Pisa](#), founded in 1343, is amongst the top research universities in Italy and has a notable reputation in Computer Science since Pisa hosted in 1969 the first Computer Science Department in Italy. The [Department of Computer Science](#) offers different MSc Programs, held entirely in English. Please **read carefully** the prerequisites and study plan rules of your target MSc Program before applying:

Applications for **non EU citizens** are open from **December 10, 2024 to February 15, 2025 (AoE)**. Candidate students should apply using the UNIFI portal:

Important dates

- [Application deadline](#): **February 15th, 2025**
- [Acceptance/rejection notification](#): **March 15th, 2025**
- Classes start: **mid September 2025**

Application Fee: starting from the 2025/2026 academic year, payment of an application fee will be required *exclusively for applicants holding a foreign qualification*.

1. **Application Requirements:** The application fee is mandatory for submitting an admission application for the 2025/2026 academic year. Each applicant may submit up to two applications for programs available on the application portal. **Please note that the application fee must be paid for each application submitted**; therefore, in the case of two applications, two separate fees will be required. Candidates who do not complete the payment will not be able to submit their application.
2. **Application Fee Amount:** The amount of the fee will depend on the applicant's country of origin, as classified by the [World Bank's income levels](#) :
 - Applicants from Low income and Lower middle income countries: €10.00
 - Applicants from Upper middle income countries: €20.00
 - Applicants from High income countries: €30.00
3. **Payment:** Payment must be made directly on the application portal <https://applymscenglish.unipi.it/>. The payment will be requested immediately after completing the application, prior to its submission to the evaluation committee.

Tuition Fees: The [annual fee for international students](#) depends on the Country of origin. University fees are to be paid each academic year and are determined annually by the Board of Directors. These fees are usually announced in June for the following academic year. Although the University of Pisa does not provide any fellowship for international students, some options for financial support are available as detailed below.

Tuition Fees Reduction: for possible reductions of tuition fees see the [University website](#).

Financial support: Fellowships can be granted to enrolled students by other organizations than the University of Pisa.

- **DSU scholarship:** Financial support is available for students, including the DSU scholarship, offered by the Agenzia Regionale [Diritto allo Studio Universitario \(DSU\)](#) of the Tuscany Regional Council. This grant provides benefits such as free accommodation, meals at the University dining halls, and exemption from university tuition fees. - **MAECI scholarship:** In addition, the Ministry of Foreign Affairs and International Cooperation (MAECI) offers scholarships each year to international students and Italian students residing abroad. For more information, please visit <https://www.esteri.it/en/opportunita/borse-di-studio/>
- **Invest your Talent scholarship:** This Master's Degree programme also participates in the "Invest Your Talent in Italy" scholarship programme, which aims to support students from selected countries and is funded by the Ministry of Foreign Affairs and International Cooperation (MAECI). Scholarships will be awarded to selected students admitted to the Master's programme. Additional information will be published as it becomes available on [Invest your Talent scholarships](#)

Selection process: In addition to a first-level Bachelor's degree, applicants must have a good knowledge of English, a solid background, high motivation, and hard working attitude. Applicants will be selected according to their graduation study performance, to the affinity of their graduation transcript exams with the target Master degree, and to any additional education or working experiences in their CV.

Notification and admission: All applicants will receive either an admission letter or a rejection notification by March 15, 2025. It is of utmost importance that **admitted students immediately start the VISA process at their local Italian Embassies or Consulates**, since in previous years many admitted students have not been able to enroll due to difficulties in getting the VISA in due time (or at all). Admitted students will have time to finalize their registration at University of Pisa until December 31, 2025, but please note that classes will start around mid September 2025, in presence in Pisa.
